In addition to the above, Anglo American Platinum has contributed funds for the deployment of hydrogen refuelling stations in California, in partnership with Shell, Toyota and Honda.

With California being a leading market for fuel cell and hydrogen technologies, membership of the CaFCP will provide us the opportunity to participate in and support the mutual goals of both our and your organisations. Our organization is well-aligned with the goals of the CaFCP and we look forward to collaborating on accelerating the adoption of fuel cell and hydrogen technologies.
